I will abide by all NCHA rules and I have been an active NCHA member continuously for two (2) years with no record of suspension, probation or reprimand by the Association for the three (3) year period immediately preceding this application; and I have been an active competitor during the past two (2) years and have won a lifetime minimum of \$10,000 or fifty (50) NCHA Youth points (worth \$200 each) or a combination of both which equals \$10,000.
