APPROVED LAE SHOW PRODUCERS COMMITTEE MISSION STATEMENT

1. Recommend the guidelines and procedures for submitting LAE show applications and their approval process.
2. Review LAE show date approvals and make recommendations on problems that may arise with overlapping dates or other situations in the allocation of show dates.
3. Make recommendations on new ideas or improvements to recognition and awards programs for NCHA- approved limited age events.
4. Protect the interest of NCHA members, the welfare of the horse and ensure that cutters in all parts of the country have access to quality Limited Age Events.
5. Protect the investments of existing Show Producers.
6. Provide opportunities for new shows and producers to be successful.
7. Each region would have a representative appointed if a Premier Event were not in that region.





STANDING RULE 4 (in part) Item #3

b. Failure to timely make payments due to Show Management. Any member that fails to timely pay when due any obligation owing to the Show Management relating to the member's participation in the show (i.e., for entry fees, stall charges, etc.) is subject to the disciplinary actions provided for in this Rule. The term "Show Management" as used herein is the organization or individual acting as sponsor of a cutting horse contest for which said organization or individual sought and received the approval of NCHA to conduct the cutting horse contest (or any other person(s) designated by said organization or individual to act on its behalf).

Show Management may take any actions it deems reasonably necessary to collect unpaid fees which it feels are in the best interest of the show, so long as such actions comply with NCHA Standing Rules. If a member feels that Show Management has not acted in the best interest of the show or has violated NCHA Standing Rules in its collection efforts, the member may file a complaint with the Executive Director. The complaint will be handled by the NCHA Grievance Committee in accordance with Standing Rule 37.

REGULATIONS FOR APPROVED LIMITED AGE EVENTS

Item #4

Monitor Fee

6.e Monitor approval fee is \$500 per day (paid to NCHA) plus the difference between actual judge pay and the \$500 per show day rate (paid directly to the monitor).

STANDARDIZATION FOR LEVELING

Item #6

- The **Intermediate Open** division can offer one of two rollback options:
 - Top 100 List in the previous two-point years
 - \$200,000 in earnings in the previous two-point years
- The **Intermediate Non-Pro and Amateur** divisions can only offer the Top 100 List in the previous two-point year rollback.
- Show Producers have the discretion to offer a rollback for Hall of Fame members.
- Show Producers have the discretion to set a senior age rollback in all divisions.
- Offering all levels is not required.
- Unapproved classes will be permitted under the condition that the class stipulations do not fit into an existing class within the NCHA Leveling Format
