

2019 NCHA World Championship Futurity

\$200,000 LIMITED NON-PRO CONTEST

(Will be a Separate Contest)

1. The 2019 NCHA Futurity \$200,000 Limited Non-Pro will be limited to Non- Pro/Amateur card holders under one of the following rules:
 - a. Non-Professionals whose eligibility earnings in NCHA- approved and/or sponsored events equal less than \$200,000 at the beginning of the point year, entry is restricted to current NCHA Non- Professional/ Amateur card hold holders.
 - b. Non-Professionals riders whose lifetime earnings are less than \$50,000 during the previous three (3) point years. (LAE & Weekend earnings) may enter the LNP separately to allow two (2) runs in the go- rounds & finals. All LNP entries must have a corresponding non-pro entry on same horse. NCHA Non-Pro Hall of Fame members are ineligible to compete.
 - c. Age 70 and above- No Money Cap If Non-Pro Card Holder.
2. Nomination fees for Limited Non-Pro Contest:

(\$1,275 jackpotted / \$225 office / \$50 NCHA fee / \$25 drug fee / \$45 processing fee)

There will be a 10-day grace period. (Official postmark by US Postal Service)
Late entries on payments postmarked after the ten (10) day grace period will be subject to a penalty of 50% of the payment. *Includes a \$20 PAC fee (optional): Under Texas Election Code, Chapter 253, the Political Action Committee (PAC) fee is a voluntary contribution. Funding the PAC is important to be able to maintain state funding at the NCHA Triple Crown. Your contribution will provide critical assistance to the NCHA with this effort. To opt out of the PAC fee, submit your payment without the amount indicated as the PAC fee for your class.
3. The \$200,000 Limited Non-Pro contest will consist of one go-round. A Semi-Finals will be held if there are 100 or more entries at the time the last payment is due. Fifty percent (50%) plus ties will advance to the semi-finals based on go-round score. The maximum

- number of horses to advance to the semi-finals will be seventy-five (75) plus ties. The high scoring twenty (20%) percent from the go-round with a maximum of thirty (30) will advance to the finals based on the semi-finals score. If a semi-finals is not held, the high scoring twenty (20%) from the go-round with a maximum of thirty (30) plus ties will advance to the finals, a maximum of five (5) sets of cattle for the semi-finals and maximum two (2) sets of cattle for the finals regardless of the number of horses. In the event there are less than twenty-five (25) entries in a class, as of October 1, 2019, there will not be a working finals. Payout will be according to the NCHA mandatory payout. All finalists will receive premium checks.
4. Riders may ride two (2) horses of any sex in the Limited Non-Pro Contest.
 5. If a rider has attempted to compete in these classes and is found to be ineligible, disciplinary action may be taken. The burden of proof of eligibility is upon the rider.
 6. All rules of the 2019 NCHA World Championship Futurity will apply in this event where applicable.
 7. The class is a stand-alone class with go-rounds held in Will Rogers Coliseum.
 8. By your signature on this entry form, you acknowledge that you are familiar with and subject to the provisions of the Medication and Drug Rules and Guidelines contained in the NCHA Rulebook. You also agree that, if requested, you will provide blood samples from your horse to comply with the random testing provisions contained in those Rules and Guidelines. Blood samples will be taken from the champion horses in all divisions. Random testing will also be performed throughout the show.
 9. By your signature on this form, you agree and acknowledge that the NCHA's acceptance of any full or partial payments for any entry does not guaranty that the entry will be allowed to show at the Futurity. All entries must meet all requirements for the class or subclass in which that are entered to show in at the time that the competition occurs. In the event that the NCHA determines, in its sole discretion, that an entry is not qualified to show in any class or subclass in which it is entered at the time of the competition under NCHA rules, you agree that the NCHA can eliminate that entry with no further liability to the NCHA.
