# GELDING STAKES

### (CONTEST WITHIN A CONTEST)

1. 2019 NCHA Derby/Classic Challenge Gelding Stakes will be limited to horses that are entered in the NCHA Derby/Classic Challenge
2. Nomination fees for Open & Non-Pro Gelding Stakes: On or before **May 10, 2019**..... **\$535** (Includes \$35 Processing fee.)  
**Late entries will be accepted after the draw, but before the beginning of the first go-round by paying a 50% penalty. In addition, a one percent (1%) deduction will be made for the NCHA Special Events Fund. There will be a 10-day grace period. (official postmark by US Postal Service).**
3. Payout will be made according to the NCHA mandatory payout, to the highest advancing horses. (no working finals).  
 a. All finalists will receive premium checks.
4. Riders may ride three (3) horses in the 4-year-old Open & Non-Pro divisions, provided at least one of the three is a gelding and entered in the Gelding Stakes. **All Open riders who have a third horse will be required**

- to submit rider changes/additions by 5:00 pm the day before the open Divisions first go-round begins. A photocopy of geldings papers must accompany this form.
5. By your signature on this form, you agree and acknowledge that the NCHA's acceptance of any full or partial payments for any entry does not guaranty that the entry will be allowed to show at the Summer Cutting Spectacular. All entries must meet all requirements for the class or subclass in which that are entered to show in at the time that the competition occurs. In the event that the NCHA determines, in its sole discretion, that an entry is not qualified to show in any class or subclass in which it is entered at the time of the competition under NCHA rules, you agree that the NCHA can eliminate that entry with no further liability to the NCHA.
6. All rules of the 2019 NCHA Derby will apply in this event where applicable.
