

# 2019 NCHA Super Stakes & Super Stakes Classic

## \$200,000 LIMITED NON-PRO CONTEST

1. The Non-Professional class limitation is based on Non-Professional earnings up to Dec. 1, 1995 plus all money won in all approved classes after that date whose lifetime earnings in NCHA-approved and/or sponsored events equal less than **\$200,000** as of January 1, 2019, and is restricted to current NCHA Non-Professional/Amateur card holders.
2. Nomination fees for Limited Non-Pro Contest:
  - On or before **Jan. 15, 2019** . . . . . \$1,630\*
  - \*( \$1175 jackpot / \$325 office charge / \$50 NCHA fee / \$25 medication fee / \$35 Processing fee.)
  - There will be a 10-day grace period. (Official postmark by US Postal Service)**
  - Late entries on payments postmarked after the ten (10) day grace period will be subject to a penalty of 50% of the payment. In addition, a one percent (1%) deduction will be made for the NCHA Special Events Fund.\*Includes a \$20 PAC fee** (Under Texas Election Code, Chapter 253, the Political Action Committee (PAC) fee is a voluntary contribution. Funding the PAC is important to be able to maintain state funding at the NCHA Triple Crown. Your contribution will provide critical assistance to the NCHA with this effort. To opt out of the PAC fee, submit your payment without the amount indicated as the PAC fee for your class).
3. The high scoring twenty percent (20%), with a minimum of six (6) and a maximum of thirty (30), will advance to the finals. Scores from the ground will determine the top twenty percent (20%).
  - a. In the event there are less than twenty-five (25) entries in a class, at draw time, there will not be a working finals. Payout will be made according to the NCHA mandatory payout, **to the highest advancing horse.**
  - b. All finalists will receive premium checks.
4. Riders may ride two (2) horses in the 4 year old division and (4) four horses of any age combination in the 5/6 year old division.
5. If a rider has attempted to compete in these classes and is found to be ineligible, disciplinary action may be taken. The burden of proof of eligibility is upon the rider.
6. All rules of the 2019 NCHA Super Stakes and Super Stakes Classic will apply in this event where applicable.
7. The class will be held in conjunction with the Non-Pro in Will Rogers Coliseum.
8. **Blood samples will be taken from Champions and Reserve Champion in all divisions, plus random samples throughout the show.**
