



# 2019 McAlister Assets & RCR Rail Co. / NCHA Super Stakes & Super Stakes Classic Unlimited Amateur Cutting Horse Class



1. The 2019 McAlister Assets & RCR Rail Co. / NCHA Super Stakes and Super Stakes Classic Unlimited Amateur class is limited to Amateur card holders under or of the following rules:
  - a. Under the age of 60, the criteria necessary for remaining in the Unlimited Amateur class is lifetime Non-Pro Limited Age Event earnings (approved classes) of less than \$100,000. Beginning with the 2016 point year, an Amateur competitor who reaches \$100,000 or more in lifetime Non-Pro Limited Age event earnings can continue to compete in Limited Age Non-Pro classes until the beginning of the next point year. At that point, the Amateur competitor must make a choice: to remain an Amateur and compete exclusively as an Unlimited Amateur or to compete as a Non-Pro.
  - b. Once an individual reaches the age of 60, if he or she qualifies under Amateur rules, they may return to the Unlimited Amateur class (LAE Events Only), regardless of Limited Age Non-Pro class money won. The member will be allowed to show in both LAE Non-Pro and LAE Unlimited Amateur competition.
2. The 2019 Super Stakes and Super Stakes Classic Unlimited Amateur Cutting Horse Contest with a minimum of 150 entries will consist of one go-round with 30% moving to the semifinals with a maximum of 60 plus ties, and with 20 plus ties to the finals. Calculations for the semifinals will be determined on the final payment date. Late entries will not dictate semifinals.
  - a. In the event there are less than 150 entries in a class, there will be no semi-finals and will consist of one go-round plus finals for the high scoring twenty-five (25%), with a minimum of ten and a maximum of thirty (30).
3. Riders may ride only two horses in the Super Stakes Unlimited Amateur and four horses of any age combination in the Super Stakes Classic Unlimited Amateur class.
4. **Nomination Fees Super Stakes & Super Stakes Classic**  
**On or before January 15, 2019 . . . . . \$1500\***  
 (\$995 jackpotted / \$375 office charge / \$50 NCHA fee / \$25 medication fee / \$35 processing fee.)  
**Late entries or payments received after the 10-day grace period (official postmark by US Postal Service) will be subject to a penalty of fifty percent (50%) of the payment. In addition, a one percent (1%) deduction will be made for the NCHA Special Events Fund.** \*Includes a \$20 PAC fee (Under Texas Election Code, Chapter 253, the Political Action Committee (PAC) fee is a voluntary contribution. Funding the PAC is important to be able to maintain state funding at the NCHA Triple Crown. Your contribution will provide critical assistance to the NCHA with this effort. To opt out of the PAC fee, submit your payment without the amount indicated as the PAC fee for your class).
5. All rules of the 2019 NCHA Super Stakes & Super Stakes Classic will apply in these events where applicable.
6. **Blood samples will be taken from Champions and Reserve Champions in all divisions, plus random samples throughout the show.**
