**IMPORTANT SHOW INFORMATION: Please read**

1. Judge

A. Approved judge recommended but not mandatory, approved judges will receive a credit. **JUDGES CANNOT JUDGE EACH OTHER.** Also added money classes must use certified judge and be named no later than seven days before the show. Judges protest system not in place for these shows.

B. If unapproved judge is used, he must have been a member in good standing for the last three (3) years, or else the results do not get processed.

The Judge must be named on page one (1) of this application.

2. Results of all Unapproved Classes held within an NCHA Challenger approved show must be submitted along with NCHA approved class results. **The \$200 show approval fee must be submitted with the show results. A \$2.00 per entry Regional fee for all weekend approved classes will be collected from contestants by the show secretary and sent to NCHA as a separate check, with the show results.**

3. Youth class must meet NCHA criteria.

4. **Attention Show Management: All classes must be video taped.**

5. In all cutting horse contests approved by the National Cutting Horse Association, the \$200 show approval fee shall be paid by Show Management and forwarded to the National Cutting Horse Association; this fee to be sent along with all completed NCHA Result Forms to the Association's office (260 Bailey Ave, Fort Worth, TX 76107) immediately following the conclusion of each contest (within five (5) days). NOTE: No deduction other than as specified as above, shall be made, **this approval fee and the Regional fee may not be deducted from the entry fee or payout to the contestants.** Failure to comply will cause approval of the show to be withdrawn.

6. **NCHA STANDING RULE 4 DOES NOT APPLY.**

Further, show management agrees to indemnify and hold NCHA harmless from and all Liability, of any, arising to NCHA by virtue of it granting us show approval, and if NCHA is sued in court of law, to defend it at our expense, and if judgment is taken against NCHA, to pay said judgment and obtain written release in form acceptable to NCHA.
