Stallion owners may have up to 1 year to amend stallion report substitution form to account for changes, updates, or amendments made to AQHA Stallion Report if a stallion changes ownership or owner buys deceased horse semen, nominator will have to request previous year AQHA Stallion Report. If such does not exist, a letter stating such to NCHA is required.
